amendment to Regulation No 29/2009 of March 31, 2009 r. with further amendments

concerning: the amount of fees for medical education in English language offered at the School of Medicine in Katowice

On the base of article 99 item 1 point 3 and item 2 of the Act of Higher Education of July 27, 2005 (Journal of Laws of 2012, item 572 with further amendments), § 17 of the Resolution of the Ministry of Science and Higher Education of October 12, 2006 for commencing and participating in studies, trainings, scientific research and development projects by foreigners (Journal of Laws No 190, item 1406 with further amendments), and § 51 item 4 of the Statute of the Medical University of Silesia in Katowice (Resolution No 30/2015 of the Senate of the Medical University of Silesia in Katowice of March 25, 2015) I hereby order the following:

§ 1

1. I settle the amount of fees for medical education in English language offered at the School of Medicine in Katowice:

- 2. Fees specified in item 1 take effect from the winter semester of the academic year 2009/2010.
- 3. Fees specified in items 1 shall be paid by the deadlines specified in the "Rules for the collection of payments".

§ 2

Rules and amount of fees due for issuing the study documentation are specified by separate Resolution of the Rector and by the "Rules for the collection of payments".

§ 3

The amount of fees specified in § 1 item 1 points 3 and 4 of the "Rules for the collection of payments" due to no satisfactory academic progress and supplement of curriculum discrepancies shall be settled by separate Resolutions of the Rector.

School of Medicine in Katowice / fee for:

- 2. Any excess payments for the fees specified in § 1 and § 3 shall not be returned to student and will be credited against current and future charges.
- 3. Final settlement of payments made throughout the entire study period will be made after graduation and in the currency in which the payments were made.

I hereby oblige the Dean of the School of Medicine in Katowice to introduce the contents of this Resolution in English language to respective students.

§ 6

I entrust the Dean of the School of Medicine in Katowice with execution of this Resolution.
