

Resolution No. 118/2024
from 19.07.2024
of the Rector
of the Medical University of Silesia in Katowice

amending Resolution No. 74/2023 from 13.06.2023

concerning: establishing the level of tuition fees for educational services provided by the Medical University of Silesia in Katowice for students commencing education in the academic year 2023/2024.

Acting pursuant to Art. 79 sec. 1 and Art. 80 sec. 1 and 3 of the Act on Higher Education and Science from 20 July 2018 (*that is, Journal of Laws from 2023, item 742, as amended*), and § 29 sec. 3 of the Statute of the Medical University of Silesia in Katowice (*Resolution no. 1/2023 of the Senate of the Medical University of Silesia in Katowice from 25 January 2023 as amended*) I hereby order as follows:

§ 1

In the Resolution no. 74/2023 from 13 June 2023 the following amendments shall be introduced:

- 1) Appendix No. 1 *Tuition fees for repeating specific classes on full-time studies due to unsatisfactory academic progress commencing from the academic year 2023/2024* shall obtain the new meaning specified in Appendix no. 1 to the hereby Resolution,
- 2) Appendix No. 2 *Tuition fees for extramural studies and for repeating specific classes due to unsatisfactory academic progress commencing from the academic year 2023/2024* shall obtain the new meaning specified in Appendix no. 2 to the hereby Resolution,
- 3) Appendix No. 3 *Tuition fees for studies in English and for repeating specific classes due to unsatisfactory academic progress commencing from the academic year 2023/2024* shall obtain the new meaning specified in Appendix no. 3 to the hereby Resolution,
- 4) Appendix No. 4 *Tuition fees for foreigners for full-time studies in Polish and for repeating specific classes on full-time studies due to unsatisfactory academic progress commencing from the academic year 2023/2024* shall obtain the new meaning specified in Appendix no. 4 to the hereby Resolution.

§ 2

The fees specified in § 1 to the Resolution No. 74/2023 from 13.06.2023 shall be applied in the amount specified in the hereby Resolution with respect to educational services provided from the academic year 2024/2025.

§ 3

I entrust the supervision over the execution of the Resolution with Faculty Deans.

§ 4

The content of the hereby Resolution shall be placed on the website of the University.

§ 5

The Resolution shall come into force on the day of its conclusion.
