

**Resolution No 71/2019  
of the Rector  
of the Medical University of Silesia in Katowice  
of April 24, 2019**

*changing the Resolution No 191/2018 of the Rector of October 12, 2018*

concerning: settlement of the amount of fees for medical education in English language offered at the School of Medicine in Katowice in the academic year 2018/2019

On the base of article 23 item 2 point 2 and item 2 of the Act of Higher Education and Science of July 20, 2018 (*Journal of Laws of 2018, item 1668*), § 51 item 4 of the Statute of the Medical University of Silesia in Katowice and in reference with § 1 items 2 of the „*Rules for the collection of payments for studies in English language at the Medical University of Silesia in Katowice*” adopted with the Resolution No 116/2013 of the Senate of the Medical University of Silesia in Katowice of June 26, 2013 with further amendments, I hereby order the following:

§ 1

1. I settle the amount of fees for medical education in English language offered at the School of Medicine in Katowice for students commencing their studies in the academic year 2018/2019:

3.	Clinical training (V and VI years of study, International program) - in Poland - outside Poland	- 302 Euro or 418 USD per 1 week - 112 Euro or 144 USD per 1 week (fixed administrative fee) and charges and costs specified in items 2 – 5	
4.	from III to V years of study – summer clerkship in Poland scheduled by the University	1 080 Euro or 1 550 USD for 4 weeks	

2. In case the Medical University of Silesia in Katowice makes cooperation agreements for clinical training with medical centers located outside Poland, fees for clinical rotations shall be made by students according to terms and conditions and in the amounts specified in these agreements, but the amount of fee per one student shall not exceed 906 USD per one week of rotation.
3. Completing clinical training in medical centers located outside Poland is optional (at student’s request) and shall be approved by the Dean of the School of Medicine in Katowice.
4. In case of completing clinical training as specified in item 2, transportation, accommodation and board expenses shall be covered by student from his/her own resources.

5. Independently from clinical training charges as specified in item 2, student is obliged to cover the costs of insurance, including liability insurance, health insurance and other, according to rules being in force in a given country.
6. Fees specified in items 1 and 2 shall be paid by the deadlines specified in the „*Rules for the collection of payments for studies in English language at the Medical University of Silesia in Katowice*” adopted with the Resolution No 116/2013 of the Senate of the Medical University of Silesia in Katowice of June 26, 2013 with further amendments, further referred to as “*Rules for the collection of payments*”.

## § 2

Rules and amount of fees due for issuing the study documentation are specified by separate Resolution of the Rector and by the „*Rules for the collection of payments*”.

## § 3

The amount of fees specified in § 1 item 1 points 3 and 4 of the „*Rules for the collection of payments*” due to no satisfactory academic progress and supplement of curriculum discrepancies shall be settled by separate Resolutions of the Rector.

## § 4

1. Fees specified in § 1, § 2 item 2 and § 3 shall be made by bank wire transfer to the following bank accounts:

## § 5

Medical students of the School of Medicine in Katowice who were admitted to the English language program:

- in the academic year 2017/2018, shall be charged the fees in the amounts specified in the Resolution No 121/2017 of the Rector of the Medical University of Silesia of August 17, 2017,
- in the academic year 2016/2017, shall be charged the fees in the amounts specified in the Resolution No 112/2016 of the Rector of the Medical University of Silesia of July 28, 2016,
- before the academic year 2016/2017, shall be charged the fees in the amounts specified in the Resolution No 29/2009 of the Rector of the Medical University of Silesia of March 31, 2009 with further amendments.

§ 6

I hereby oblige the Dean of the School of Medicine in Katowice to introduce the contents of this Resolution in English language to respective students.

§ 7

I entrust the Dean of the School of Medicine in Katowice with execution of this Resolution.

§ 8

The contents of this Resolution ought to be announced on the University website.

§ 9

This Resolution becomes effective on the day of its signing.
